Instructions to the Candidates

- I. The fee once paid will not be refunded or adjusted under any circumstance.

- II. Applications after the stipulated date will not be entertained on any grounds.
- III. The fees should be paid by the students through **online payment** on or before the stipulated time
- IV. Students on roll have to pay the examination fee by online payment mode through Mycamu by individual login. Students have to download mycamu app from play store and register by getting PIN from college for the online payment. Student's email and contact number to be utilized and this can be updated by the students themselves in Mycamu. After entering it must be approved by the admission section of the respective college to enable the students to make payment online through patytm.
- V. All final year students are informed to register in NAD (National Academic Depository) and mention the NAD ID in the application.

Instructions to the Dean/Principal/head of Institutions

• **Remittance of Examination Fee:**

- i. All applications for registrations should be forwarded to COE accompanied by the prescribed fee payment evidence.
- ii. Those candidates who have shortage of Attendance and have not obtained minimum IA marks are not eligible for appearing the examination. If there is any deviation, Dean/Principal/Head of Institution are solely responsible for any lapses in this regard.
- iii. Even If student pays exam fee without fulfilling the Regulations requirement, he will not be permitted to appear for Examinations.
- iv. No other fees should be collected from the candidates for this examination purpose.
